1. Executive Order No. 1: Dated March 17, 2020 by order of William "Doc" Schmitz, VFW National Commander-in-Chief: "Pursuant to the authority under Section 618(a)(4), effective immediately and until rescinded, we ask that Posts, Districts and Departments, if possible and within the requirements of mandated State Declarations, make the attempt to elect officers. For such Posts, Districts or Departments that are not able to elect officers as a result of COVID-19, all current officers shall continue to function within their capabilities until new officers are elected. It is further stipulated that no Post, District or Department be sanctioned as result of the inability to properly functions, as mandated by state or local government declarations, as a direct cause of COVID-19."

POSTS WILL NOT BE PENALIZED FOR MISSING DEADLINES.

2. Cancellation of the 2020 VFW National Convention in Reno, Nevada: On April 20th, in the wake of COVID-19, the Veterans of Foreign Wars officially cancelled the 2020 VFW National Convention scheduled to be held in July 2020 in Reno, Nevada.

This year will mark the first in the organization's storied 121-year history where a National Convention will not be held. The VFW Auxiliary has also cancelled its Convention. The next VFW National Convention will be held in Baltimore, Maryland on July 31 - August 5, 2021.

3. **VFW Post & District meetings can be held:** The Governor's Executive Order GA-18 as interpreted by the State Commander does allow for Posts and Districts to conduct VFW meetings provided the persons present do not exceed 25% of the stated building capacity. As an example, a Post that has a capacity of 100 could not have more than 25 people in the building or room if other rooms have a stated capacity as some of our Posts do.

Also, many Posts and Districts are under stricter requirements from City and County officials. According to the VFW National Commander-in-Chief, if you can have your meeting and elections great; if you need to postpone and rescheduled and have it in June (provided we are in the all clear), then great.

I am in concurrence with the Commander-in-Chief and would rather you all be safe then risk yourself for fear of being disciplined for not having a meeting. We have been around for 120+ years, we can wait a month to get back to business as normal.

4. **Texas Governor Abbott Re-Opening Operations:** Texas Governor Greg Abbott has announced that on May 1st, that retail stores, dine-in restaurants, movie theaters, shopping malls, Museums, Libraries, Golf course operations and specific local government offices can open provided that they do not exceed no more than 25% of their capacity. For some counties that have had 5 or less cases with approval may operate the above listed business at 50% capacity. Social distancing is still required to be practiced at these locations.

His Executive Order went on to say the following: "People shall avoid visiting bars, gyms, public swimming pools, interactive amusement venues such as bowling alleys and video arcades, massage establishments, tattoo studios, piercing studios, or cosmetology salons."

This announcement would prohibit most--if not all VFW Posts from being able to reopen their canteens. Please check with your local officials before opening your Post up for Bingo or V-Sweeps.

- 5. **District Convention Meetings:** VFW National By-Laws for District Quorum require 50% of at least 1 delegate from each Post in the District to transact business which includes elections. As an example, a District with 14 Posts would need at least 50% representation of the 14 Posts meaning that 1 delegate from at least 7 Posts would need to be present to hold the District Convention.
- 6. **Post & District Election Reports:** Post and District Election Reports can be completed online at the VFW National website on the Online Membership System (OMS). Post Quartermasters and District Quartermasters need to complete the reports soon after the Post and District elections are held in May or June.
- 7. **All-State Deadline:** The deadline for All-State has been extended to Saturday, May 16th for all requirements not met prior to March 16, 2020. However, each Post has until June 30, 2020 to attain 100% in membership as that requirement is still required for All-State recognition.
- 8. **All-State Recognition Items:** All-State recognition items (such as Post All-State Plaques, VFW Overseas caps, lapel pins and recognition medals, etc.) can be ordered and purchased by completing the "All-State Post Entry Form." The form can be found on the Texas VFW website in the Standard Operations Procedure (SOP).

9. The 3rd Quarter Post/District Audit Report-Deadline Extension: As your State Commander, I have had many questions asked regarding the 3rd Quarterly Post/District Audits.

The deadline for the 3rd Quarter Audit Report has been extended to May 16th.

I am asking that every Post and District to adapt, overcome and improvise in getting their Quarterly Audit completed and sent in. If you feel comfortable having the three Trustees, Quartermaster and Commander of the Post meet to complete the Quarterly Audit, then do so.

If you would rather use email with electronic signatures as we do at the Department level with DocuSign, then do so. If you can email the Audit and have them send back a response affirming that they are signing the Audit, then do so as long as we have a copy of the email stating they agree with the Audit. If you want one person to drive to each person's house to have them sign, then go for it. If you want the Trustees to come to the Post staggered in one or more hour increments even spread out over several days, then do so.

10.**Post Insurance:** I have had several calls about insurance companies refusing to accept a delay in monthly payments. Comrades, all I can say is that if your Post is closed and you do not have insurance then you cannot open till you have insurance.

For those Posts that may be adversely affected financially by such closures, such Posts should see if they have any insurance policy, such as Business Interruption Insurance, in effect.

Posts should consult with their respective insurance provider for questions. Additionally, the U.S. Small Business Administration (SBA) may provide some relief. The SBA's Economic Injury Disaster Loans offer up to \$2 million in assistance and can provide vital economic support to small businesses to help overcome the temporary loss of revenue they are experiencing.

These loans may be used to pay fixed debts, payroll, accounts payable and other bills that can't be paid because of the disaster's impact. The interest rate for non-profits is 2.75%. Terms are determined on a case-by-case basis, based upon each borrower's ability to repay.

11.**State Convention Delegates Fees:** Per the State By-Laws, we are required to send out an invoice to each Post for State Convention Delegate fees based off Post membership as of April 1st of each year. As the State Headquarters staff is under "Work from Home" orders from the City of Austin and Travis County, we have had to adapt to how this will be done.

Wayne Cooley, State Assistant Adjutant, has sent each District Commander Post Delegate Invoices for each Post in their respective District. Invoices will also be posted on the Texas VFW website link noted below:

As the COVID-19 Virus can live for up to 24 hours on paper, the State Headquarters will not be mailing these delegate invoices to the Posts. I know all 302 VFW Posts currently in Texas will suddenly claim they do not have access to a computer. This is where the District Commanders come into play as I am asking our District Commanders to contact their Posts and either direct them to the Texas VFW website to download the form or email the form to State Headquarters.

We will also have it set up so Posts can pay their delegate fees online and email or, as a last resort, fax in the delegate form with the names of those who had been elected. As a reminder, the State Convention Delegate fees are \$3.00 for every delegate a Post is entitled to which is one (1) delegate per every thirty (30) members or partial thereof.

- 12.**The Texas VFW Foundation**: The Texas VFW Foundation is ready for the large influx of assistance claims for individual veterans who have lost wages or been adversely affected due to COVID-19. Refer veterans to the Texas VFW Foundation website. https://www.texasvfw.org/foundation
- 13.**Department Anniversary:** The Department of Texas VFW will be turning 100 years old in 2020. As State Commander, I am asking that all VFW Posts provide a listing of veterans within their Posts who are either and/or will be 100 years old in 2020. - 18.**Proof of Eligibility Requirements for incoming 2020-2021 District Officers:** Proof of eligibility for the following positions are to be submitted to the Department of Texas VFW Headquarters no later than June 15, 2020:
 - District Commander
 - District Senior Vice Commander
 - District Junior Vice Commander
 - District Quartermaster
 - District Adjutant

If proof of eligibility is not submitted within thirty (30) days of the election, your office will be declared vacant and your eligibility will be challenged.

If the incoming District officer for the above-mentioned positions previously submitted "proof of eligibility"—there will be no need to resend to Department of Texas VFW Headquarters.

22.**100**th **Annual Department of Texas VFW State Convention:** Currently we are still planning on having our State Convention in Austin to be held June 17-21, 2020. However, depending on the restrictions in place we may have to modify to accommodate.

Currently the State Convention is scheduled to be held at the DoubleTree Hotel by Hilton Hotel Austin (6505 North Interstate 35, Austin, Texas 78752).
