**GENERAL ORDERS** 2020 - 2021 Series 

1. Section 214: Posts in violation of Section 214 of the By-Laws and Manual of Procedure (solicitation of funds) are subject to suspension. Contracts must be forwarded to and approved by Department of Texas VFW State Commander. Currently we have an exclusive 10-year contract approved by the Council of Administration in 2017-2018 with V-Sweeps.

Eight-liners, skill machines, other Sweepstakes and similar devices are not authorized at

this time.

2. Post Nominations/Election of Officers: In accordance with Section 217 of the Manual Procedure, nominations of Post Officers should have been opened in March and election of Officers shall be concluded in April. **NOTE:** Post election reports should be filed shortly after the final nomination and election of officers at the April meeting by going to the Online Membership System (OMS) on the National VFW website. For those Posts who cannot complete the election report, please forward it to the Department of Texas VFW Headquarters.

- 3. District Nomination/Election of Officers: Elected Officers shall be nominated and elected at their respective District Convention and shall be conducted in accordance with the Manual of Procedure. Officers shall not assume office if they are in arrears in their yearly dues. Any Officer who during their term of office does not pay their dues when due, will be removed by National Headquarters and will not be able to assume any office for the remainder of the current calendar year. District Commanders, District Senior and Junior Vice Commanders, District Adjutants and Quartermasters once upon being elected and installed will provide a copy of their discharge papers (DD-214s) to the Department of Texas VFW Headquarters. NOTE: Check with the Department of Texas VFW Headquarters to confirm if your DD-214 is already on file by contacting Wyonda Laurence, Department Secretary: wyonda@texasvfw.org.
- 4. Proof of Eligibility Requirements for Officers: All Posts, Districts and Departments should be reminded of the provisions of Sections 216, 416, and 516 of the Manual of Procedure that officers, elected and appointed, shall not be installed, or assume the duties of their office until proof of eligibility has been submitted to the respective Adjutant and properly reviewed.

- 5. <u>Resolutions for Department of Texas VFW State Convention</u>: VFW Posts desiring to submit resolutions for consideration by their District prior to convening of the State Convention must present the resolution to their District in time for their District Convention and upon approval by the District, copies of the resolution must reach the Department of Texas VFW State Adjutant, Dan West, in time to be prepared for the State Convention.
- **6.** <u>ALL-AMERICAN DEADLINE</u>: The deadline for All-American for Posts and Districts is June 30<sup>th</sup>. - 7. <u>Department of Texas VFW Headquarters in Austin is currently closed to visitors until further notice.</u>
- **8.** MODIFICATIONS TO QUALIFICATIONS FOR ALL-STATE: Due to the length of time the State of Texas was closed for COVID regulations, I am modifying the All-State Program to allow for any Post, even those who are late on a program item, to qualify for All-State.

This applies mainly to VPR's & Community Service and you must submit the missing program on the correct report form, preferably online: <a href="https://www.texasvfw.org/">https://www.texasvfw.org/</a>.

You cannot get credit for Voice of Democracy or Patriot's Pen if you did not do them. You will also be disqualified from being in the top 4 of your Membership Division, meaning that you would not receive your All-State recognition items for free, you would have to purchase them if you want them.

I have also extended the deadline date for All-State out to June 30<sup>th</sup>. This to afford Posts an opportunity to attain their membership goal and still become an All-State Post.

Those qualifying for All-State after May 2<sup>nd</sup> will be recognized at the Department Officer Training Seminar in July.

- **21.** Status of Texas State Legislative Bills: Mitch Fuller, Director of Governmental and Public Affairs & State Legislative Chairman has been attending Legislative Hearings at the Texas State Capitol. Below is the information on one of the Senate Bills:
  - **SB 1493 (Springer)**—This Senate Bill is still pending in the Senate Business & Commerce Committee after the recent hearing/testimony. Hopefully, we will see movement out of Committee next week or at least an update on progress. This is the bill that prevents Veteran Service Organizations with a TABC license from closure under section 418 of the Texas Code.
- 22. Reminder for Post Commanders (per State Commander Shawver): Reminder for all Post Commanders of Section 218(a)(1) Paragraph c. Insist that Post business and activities be conducted in such a manner that they do not violate any applicable governmental law, ordinance or regulation nor bring or tend to bring dishonor or embarrassment upon the Post, its members, or the Veterans of Foreign Wars of the United States.
