6. VFW National Commander-in-Chief's Homecoming:

The VFW National Commander-in-Chief's Homecoming that was scheduled to be held in August 2020, has been rescheduled for March 24-28, 2021, in Portsmouth, Virginia.

7. **VFW Posts with 8-Liner Vendors:** In the last few years, the Department of Texas VFW Headquarters staff has had the opportunity to look at two (2) different contracts that were signed by VFW Posts with an 8-liner vendor. Both of these contracts had the following paragraph in them: "At all times, Proprietor agrees to operate the Games and conduct redemption in full compliance with all city, county, state, and federal laws and regulations, including but not limited to Chapter 47 of the Texas Penal Code".

In layman terms, this is a complex area of State Law in Texas. The key legislation is Penal Code Section 47.01(4). Sometimes 8-liners conform to the definition of this law. However, more often they do not. As per this law, 8-liners that are strictly used for amusement are legal. This means that the players can only win novelty items or cash prizes up to a maximum value of \$5. Any 8 liner that pays out cash more than \$5 is illegal.

So basically, as a Post, you are agreeing that any prizes will be in accordance with Chapter 47 of the Texas Penal Code. Chapter 47 includes language that exempts certain electronic machines solely for bona fide amusement purposes. They meet that definition if the "contrivance rewards the player exclusively with noncash merchandise prizes, toys, or novelties, or a representation of value redeemable for those items, that have a wholesale value available from a single play of the game or device of not more than 10 times the amount charged to play the game or device once or \$5, whichever is less".

The Vendor of the machines is washing his hands if you get busted because within his contract you, the Post Officer who signed the contract agreed to operate them in accordance with state law. Good luck getting those vendors to pay your legal costs if and when you get busted. The Vendor takes on no liability here, the Post does. All a Vendor is going to say is "I did not know they were paying cash!"

- 10.**Post Audits:** The (original) signed copy should be mailed or emailed to Department of Texas VFW Headquarters. Deadline dates for Post Audits for the remainder of the 2020-2021 Administrative Year:
 - 1st Quarter Post Audit Report was due by October 31, 2020
 - 2nd Quarter Post Audit Report is due by January 31, 2021
 - 3rd Quarter Post Audit Report is due by April 30, 2021
- 11.**Deadline to submit 2019 IRS form:** December 31, 2020, is the deadline to submit a copy of your Post IRS Form, 990, 990EZ, or 990N. Copies should be mailed or emailed to Department of Texas VFW Headquarters.
- 12. **Deadline for all Post Inspections due by December 31, 2020:** Post Inspections should be completed and received (mailed or emailed) to the Department of Texas VFW Headquarters no later than December 31, 2020.

- 17. Deadline to receive Veteran Project Participation Report (VPR) for Women in Military Service: November 17, 2020, is the due date for the VPR for Women in Military Service to be submitted to Department of Texas VFW Headquarters.
